SECTION 4: First aid measures

4.1. Description of first aid measures

Contact with skin

Take off contaminated clothing. Wash the exposed parts of the skin thoroughly with water and soap. Consult a doctor if disturbing symptoms appear.

Contact with eyes

SECTION 5: Firefighting measures

5.1. Extinguishing media
